### SUMMARY

The Maintenance Manager will be expected to provide maintenance department leadership, direction, planning, supervision, technical support and assistance to ensure the safe and efficient operation of a Mini Milling and Blending facility. The area of responsibility is the entire facility. General equipment and facility maintenance as well as electrical and mechanical trouble shooting, installation, and maintenance fall within the scope of this position description. Knowledge of physical plant electrical systems, medium voltage systems, and Programmable Logic Control (PLC) systems is required. Knowledge of process flow and mechanical aptitude is required to fully meet the expectations of this position. Responsible for preventative maintenance, plant project efforts, cultivating excellence initiatives, and plant budget considerations relative to all plant operations.

# **ESSENTIAL DUTIES AND RESPONSIBILITIES** include the following. Other duties may be assigned.

- 1. Mechanical performance and reliability of the processing machinery and facility to include building maintenance and infrastructure such as fire systems.
- 2. Develop new and maintain or update existing Preventative Maintenance schedules and routines as needed.
- 3. Coordinate all outside contractors and OEM manufacturer visits and work within the facility.
- 4. Oversee installation and repair all mechanical and electrical
- 5. Take an active role in providing training and direction for personnel on proper safety practices, operating procedures, the plant integrated quality systems, and company policies and procedures.
- 6. Obtain a minimum of a green belt certification within one year of hire date and complete a minimum of two CE projects annually.
- 7. Develop and document an effective training program relative to information systems (Computer Systems, Network Maintenance, DBC, and e-maintenance) consistent with the entire plants management information needs.
- 8. Reviews and recommends Operating Budget items to Plant Management.
- 9. Reviews and recommends Capital Budget items to Plant Management.
- 10. Communicate critical maintenance concerns with all plant personnel.
- 11. Trouble shoot electrical, mechanical, and operational challenges and direct the staff on proper repairs and procedures.
- 12. Carries out manager responsibilities in accordance with the organization's policies and applicable laws.



- 13. Responsibilities include interviewing, hiring, and training employees; planning, assigning, and directing work; appraising performance; rewarding and disciplining employees; addressing complaints and resolving problems.
- 14. Identification and correction of true root cause.
- 15. Prompt address of temporary repairs.

**QUALIFICATIONS** To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed below are representative of the knowledge, skill, and/or ability required. ## **EDUCATION and/or EXPERIENCE**

A degree from an accredited technical college and a minimum of 5 years of on the job experience desired.

### LANGUAGE SKILLS

Must have the ability to speak fluent English as primary language. Must have the ability to read, analyze, and interpret memo, technical procedures, or governmental regulations. Must have the ability to write in English and complete reports.

### MATHEMATICAL SKILLS

Ability to work with mathematical concepts and apply concepts such as addition, subtraction, multiplication, division, fractions, percentages, ratios, and proportions to practical situations.

## **REASONING ABILITY**

Ability to define and solve problems collects data, establish facts, and draw valid conclusions. Ability to interpret an extensive variety of technical instruction in mathematical or diagram form and deal with several abstract and concrete variables at any given time.

## CERTIFICATES, LICENSES, REGISTRATIONS

On-going training to enhance performance in position as required.

## SAFETY

- 1. While performing the essential job functions, the employee is expected to work in a safe manner and follow company policies regarding safety.

- 1. While performing the duties of this job, the employee is regularly required to sit, use hands to finger, handle, or feel; reach with hands and arms; and talk and hear.
- 2. Employee is frequently required to stand, walk, climb or balance, and must occasionally lift and/or move up to 100 pounds.
- 3. Specific vision abilities required by this job include close vision, distance vision, and ability to focus.

**WORK ENVIRONMENT** The work environment characteristics described here are representative of those an employee encounters while performing the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

- 1. The work environment is essentially in a plant manufacturing facility, containing various amounts of dust in the atmosphere, related to the cleaning and milling of wheat.
- 2. Frequent contact with operational aspects of the plant site, plant-operating personnel, and lab and office employees is essential.
- 3. While performing the duties of this job, the employee is occasionally exposed to moving mechanical parts, fumes, or airborne particles, and outdoor temperature, which will reach in excess of 100 degrees F.
- 4. The noise level in the work environment will be in excess of 100 dB. Hearing protection is required in certain areas of the plant.



## FOOD SAFETY / SECURITY REQUIREMENTS

The Company is committed to producing and delivering defect-free products. To ensure this, all employees are required to be trained on and adhere to the Good Manufacturing Policies set forth by the Company as they pertain to personnel practices, equipment, and facilities. It is also vital that all employees be aware of the work environment and when possible, prevent accidental or intentional adulteration of products produced at this facility. As a result any employee has a right to put product on hold if they have a concern. At the plant level, only the Quality Assurance Manager and General Manager have the authority to release product on hold.
