#### SUMMARY

This position is responsible for all facets of purchasing management for ingredients used by the Mini-milling and Blending (MMB) business unit. This position requires management of the procurement administrator function. Sourcing trips around the globe are required throughout the year and depend on supplier availability and growing seasons.

# **ESSENTIAL DUTIES AND RESPONSIBILITIES** include the following. Other duties may

be assigned.

- Develop and implement procurement and price management strategies for all the ingredients used by the business unit. Some of these ingredients include edible seeds, ancient grains, and beans, pulses, and legumes.
- Lead and manage vendor approval and raw material approval processes and programs for all ingredients. Cultivate a vendor base that optimizes business unit performance.
- Conduct formal ingredient presentations to senior management and key blending and milling customers.
- Establish in-transit and physical inventory scheduling and maintenance strategies and maintain commodity purchasing positions.
- Publish regular market commentary to internal and external blending and flour milling customers. Serve as a pricing resource for blending sales and the Product Development Team.
- Participate in the development and execution of the business unit budget. Assist in establishing short-term and long-term business goals. In areas of responsibility monitor progress and evaluate results.
- Team with Operations, Product Development, Quality Assurance, Sales, and Transportation to maximize individual performance and business unit results.
- Work with the Supply Chain Manager and Commercial Manager to develop strategies for ingredient risk management.
